SUMMER (State League) COMPETITION STARTS 4th AUGUST 2009...Games will be played at MSAC and MHS pools and generally structured as per previous seasons:

- **Division 1 Women** Tuesday nights SL1, SL2, JnrW, YthG
- **Division 1 Men** Wednesday and Thursday nights SL1, SL2, JnrM, YthB
- **Other Divisions** Tuesday and Thursday nights SL3, SL4, SL5
- **Junior Men/ Women** will be 18 & Under (ie born 1990 or later)
- **Youth Boys/ Girls** will be 16 & Under (ie born 1993 or later)

An official draw will be forwarded to your Team Manager for distribution when available from VWPI.

YOUR COMBINED CLUB & VWPI FEE COVERS...All costs for the year including VWPI Registration, Club Membership, Sports Insurance, VWPI Game Fees (Club Challenge extra), Training and a Club Towel.

POOL ENTRY...You will be required to identify yourself as a Water Polo Player when you enter the pool. If you already have a MSAC card (either charged or expired) this will suffice. If you do not have a card and wish to purchase one, Members can purchase cards directly from MSAC Customer Service staff. If you do not wish to purchase a card, VWPI will issue a 'Player Pass' card (to be distributed through the Club), but these will not offer any priority access/time limit to carparking, etc..

FEES MUST BE PAID TO PLAY AND TRAIN...If not, your sports insurance coverage will not apply and VWPI/MCWPC will not accept responsibility for non-financial members.
